#### **AGENDA**

**1. CALL TO ORDER:** Erica Rintoul, Secretary, called the meeting to order at 7:02 pm. Lynda Ruckman, Treasurer 2<sup>nd</sup> the motion.

## 2. CERTIFY QUORUM

- In attendance were all directors: Lynda Ruckman, Erica Rintoul, and Cole Connor thereby establishing a quorum. Also in attendance were members Chris Russick, Rob Newton, Dan Piparo, and Ernie Salazar.
- Corey Palmer was in attendance, representing Ameri-Tech.
- Notice of the Meeting was delivered to all Association members by email and posted on the community bulletin board. Notice of the meeting met the 48-hour requirement.
- 3. APPROVAL OF PREVIOUS MEETING MINUTES: Lynda motioned to approve the meeting minutes from July 9, 2025. Cole second the motion. The motion carried.

#### 4. TREASURERS REPORT

• Lynda noted that with 5 roofs almost complete, reducing the reserve funds substantially. HOA fees will be increasing to \$470 starting September 1, 2025, to help replenish funds. Extra funds will go directly to the reserve funds.

- Fire extinguisher boxes and signs have been replaced. Fire extinguishers have been inspected. Extras are in maintenance room.
- Shutters Additional shutters are being ordered to replace on Building 4 and others as needed.
- Maintenance room and pool keys have been adjusted. Corey will get spare keys to restrooms
- Wind mitigation report Cole and Nicole is coordinating date/time with Corey and homeowners.
- There will not be a board meeting in August do to travel schedules.

# 6. NEW BUSINESS

- Roof Update: Building 4 is done. Building 5 is underway. All 5 to be completed before wind mitigation report can be completed
- Board member vacancy: President and Vice President roles are open.

## 7. HOMEOWNER COMMENTS

 Dan Piparo - Asked if a special assessment had been discussed instead of raising the HOA fees. Lynda explained yes, a special assessment was discussed but the board

- agreed that the best path forward was to raise the fees instead as we are building reserves for the future instead of trying to cover the current cost.
- Chris Russick Is there a target number for our reserves? Lynda stated that the goal is to rebuild the reserves to \$500k in 10 years.
- Corey confirmed that most homeowners have submitted insurance documents. There are a few outstanding that they are still trying to get.

**ADJOURNMENT:** Lynda motioned to adjourn the meeting at 7:42pm. Erica second the motion. All in favor and the motion carried.
